

ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION AGREEMENT

In consideration of my being allowed to use the services of TR HANNON ENTERTAINMENT LLC, its owners, officers, employees volunteers, participants and all other persons or entities acting in any capacity on their behalf (herein after referred as "Urban Jungle"), I HEREBY ACKNOWLEDGE AND AGREE to the following:

1. ASSUMPTION OF RISK: I hereby acknowledge, accept and agree that rock climbing, laser tag and the use of Urban Jungle’s facilities is potentially dangerous. I received full information regarding Urban Jungle’s facilities and had the opportunity to ask any questions that I wished. I have full knowledge of the nature and extent of all the risks associated with rock climbing, laser tag and the facilities of Urban Jungle, including, but not limited to:

ROCK WALL – All manner of injury resulting from falling off the climbing wall and hitting the floor, bouldering pads and corners of such pad, the climbing wall, rock face, people or projections whether permanently or temporarily in place; Rope abrasion, entanglement and other injuries resulting from activities near the rock wall such as but not limited to, climbing . belaying, rappelling, lowering on ropes, rescue systems, and any other rope techniques; Injuries resulting from actions or omissions of others, including but not limited to falling climbers or dropped items, such as, but not limited to, ropes, climbing hardware, wall parts or personal effects; All manner of injury resulting from contact with the rock wall, including but not limited to cuts, abrasions, and broken bones. **LASER TAG** – All manner of injury resulting from playing the game of laser tag, including but not limited to falling from platform structures, contact with any structure, falling from or around ramp structures or any part of the maze structure; Injuries resulting from actions or omissions of others, including but not limited to, contact with others, such as but not limited to collisions; Injuries resulting from game equipment, including but not limited to falling equipment from the arena and any contact with laser guns, vests, or any other equipment within the game; All manner of injury resulting from contact with any game structure or any players or employees within the game, including but not limited to, cuts, abrasions, broken bones, concussions.

FACILITY: All manner of injury from failure to follow Urban Jungle’s employees’ instructions or failure to ask for information or assistance.; All manner of injury resulting from my movement through the Urban Jungle facility, including but not limited to, cuts , abrasions, broken bones, concussions, caused by slips, trips, falling down steps, and all other manner of falls.

I further acknowledge that the above list is not inclusive of all possible inherent risks associated with the use of Urban Jungle, and I agree that such list in no way limits the extent or reach of this assumption of risk, release and indemnification agreement.

2. RELEASE: In consideration of my use of Urban Jungle’s facilities and/or participation in any program, competition, special event, camp, group or party offered by or held at Urban Jungle’s facilities, I hereby release and discharge Urban Jungle, from any and all liabilities, suits, claims, demand actions or damages (including attorneys’ fees and disbursements) and losses or costs of any nature whatsoever incurred by me or that are in any way related to or arising out of the use or intended use of Urban Jungle’s facility, whether supervised or not, including, without limitation, all claims for property damage, personal injuries or wrongful death including any such claims which allege negligent acts or omissions of Urban Jungle.

3. INDEMNIFICATION: I hereby agree to Indemnify Urban Jungle, from any and all causes of actions, claims, demands, losses and costs of any nature whatsoever arising out of, or in any way relating to, my use of or movement in or throughout Urban Jungle’s facilities, including any such claims which allege negligent acts or omissions of Urban Jungle.

I understand and agree that Urban Jungle reserves the right to deny access to its facilities to any individual, permanently or for a specific period of time, for any breach of Urban Jungle’s policies, rules and regulations or for any conduct that is viewed as unsafe or inappropriate. I permit Urban Jungle to capture any form of media, be it photo or video, and agree that any such media may be used for any and all purposes that Urban Jungle sees fit. I also agree that Urban Jungle may add my e-mail address to its mailing list. By signing this agreement, I waive the right to bring a court action to recover compensation or obtain any other remedy for any

injury to me or my property or for my death, however caused, arising out of my use or movement in or throughout Urban Jungle’s facilities, now or any time in the future, whether caused by negligence on the part of Urban Jungle or not. I agree to pay for all legal fees incurred by Urban Jungle as a result of any claims made by me or on my behalf in violation of this agreement.

I am at least 18 years of age and otherwise legally competent to sign this agreement (if under the age of 18, this release must also be signed and filled out below by the parent or guardian of the minor). This assumption of risk, release and indemnification shall be effective and binding upon me and upon my assigns, heirs, representatives, executors and administrators. My participation in any activities at Urban Jungle is purely voluntary and I elect to participate in spite of the risks. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in any of the activities at Urban Jungle, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition. I agree that the validity and enforceability of this release of liability and assumption of risk will be governed by the substantive law of the State of Georgia, without regard to its conflict of law rules. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I have had sufficient opportunity to read this entire document. I have had the opportunity to ask questions about this document and its content. By signing this document, I acknowledge that if anyone is hurt or property damaged while I am on the premises of Urban Jungle, I may be found by a court of law to have waived my right to maintain a lawsuit against Urban Jungle on the basis of any claim from which I release them herein.

This Assumption of Risk, Release and Indemnification Agreement will remain on the premise of Urban Jungle and will be in effect at all times from the date signed that I use the facilities of Urban Jungle, regardless of any changes or modifications to the facility.
